

The School

Context

Launceston Christian School is a Christian school community in the Tamar Valley in Northern Tasmania. We are a registered Kindergarten to Year 12 day-school with a total enrolment of 673 students. The School is owned and operated by an Association - Launceston Christian School (Inc.). The School exists to enter and maintain strong partnerships with parents who desire their children to be taught from and equipped with a biblical world view. Situated on about 12 hectares, LCS is in the Launceston suburb of Riverside, on the western bank of the Tamar River.

Staff Attendance & Retention

The average, daily rate of attendance for teaching staff at Launceston School in 2019 was 97.06%.

In 2019, fifty-seven teachers continued in active employment from 2018. At the end of 2019, a total of fifty-nine teachers were actively employed at Launceston Christian School. Of these, three teachers took maternity leave, and another left to take up an Assistant Principal position at an interstate school.

All teachers employed at Launceston Christian School in 2019 were registered with the Tasmanian Teachers Registration Board (TRB).

Professional Learning Expenditure and Teacher Participation

In 2019 a significant focus for Professional Learning was the International Transforming Education Conference (ITEC). This three-day conference was held in Adelaide, with the theme being "Reimagining Practice". A significant majority of Staff, including many Board Members, attended the conference, with Keynote addresses from Dr David Smith, Jefferson Bethke, Stephen McAlpine and Dr Patricia Weerakoon. Given the School's focus on this conference, externally provided Professional Learning was limited in 2019.

Depending on previous training completed, all Staff completed either the "CPR refresher" course or the "Provide first aid" course, through St John's Ambulance at the start of the school year.

Key Learning Area Coordinators attended Network Meetings and Years 7-10 Moderation Workshops provided by the Tasmanian Catholic Education Office.

Years 11 and 12 teachers attended Course Moderation Meetings provided by the Department of Education as well as TASC Quality Assurance meetings, where required.

The Education Support Unit staff participated in three significant professional learning opportunities. The first of these was with Mrs Pam Johns on 'Behavioural Triggers and Supports for Students' the Junior School staff also attended this session. The second opportunity was run in-house by Mrs Natalie Polis and was a facilitated study day with teacher aide staff researching and presenting to each other on various disabilities. Yearly professional learning on work, health and safety and the induction to the technology workshop were also undertaken.

During 2019 Junior School staff focused on a regular schedule of moderation for English and Mathematics following refresher training in how to apply the Swing Protocol. Staff continued to develop a Junior School approach to pastoral care. They completed sessions on a biblical perspective of emotions and developed age-appropriate strategies for teaching emotional intelligence. Staff also worked in cluster groups as part of the Reflective Practice Program based on improving teaching practice.

The Middle and Senior Schools completed 'in house' professional learning in Classroom Management, the development and refinement of Scope and Sequence documents for Australian Curriculum and TASC Courses, and the National Consistent Collection of Data for students with disabilities.

A positive percentage in the right-hand column is indicative of improvement between 2018 and 2019. A negative rate indicates that the percentage in 2018 was higher than that in 2019.

The number of students in each Year group at Launceston Christian School is relatively small, and the figures do not compare results for the same group of students. It should be recognised that, at various levels in the School, new students are enrolled between one year and the next. We have noted that this can have a disproportionate impact on the proportion of students testing as below the benchmark.

The School remains committed to improving literacy and numeracy standards for all students, including its commitment to the 'performance target' of having all students performing above the National Minimum Standard.

Senior Secondary Outcomes

School Performance and Forward Planning

Student Welfare

LCS hosted student workshops and community seminars titled #NotEvenOnce - Changing the Narrative which were coordinated and run by Teen Challenge Tasmania. The "Changing the Narrative" theme provided students, parents and community members with information on the current alcohol and drug culture, and the impacts of various common drugs on developing brains and bodies. It also presented some of the underlying reasons for individuals to begin using drugs and alcohol, as well as some of the markers that indicate use.

Workplace Health and Safety

The School's Workplace Health and Safety Committee meet once every term to review incidents, potential hazards, risk assessments and incursion/excursion debriefs. The Committee reports to the Board on their deliberations, including any resolutions and recommendations arising.

Policy Management

The School continues to use the *Complispace* policy management tool for all its policies. The Board of Directors and the Leadership Team of LCS regularly review the School's policies and update or adjust where appropriate.

Several policies were updated throughout 2019. Most notable among these were the Behaviour Management Policy and Drugs and Alcohol Policy.

Strategic Plan

The Leadership Team continued to work on the next Strategic Plan for the School with input from key stakeholders. The Plan reached the final draft stage at the end of 2019, ready to be printed in early 2020.
