

## The School

#### Context

Launceston Christian School is a Christian school community in the Tamar Valley in Northern Tasmania. We are a registered Kindergarten to Year Twelve day-school with a total enrolment of 689 students. The School is owned and operated by an Association - Launceston Christian School (Inc.). The School exists to enter and maintain strong partnerships with parents who desire their children to be taught from, and equipped with, a biblical worldview. Situated on about 12 hectares, LCS is in the Launceston suburb of Riverside, on the western bank of the Tamar River.

### Staff Attendance & Retention

The average daily rate of attendance for teaching staff at Launceston Christian School in 2020 was 98.36%.

In 2020, fifty-three teachers continued in active employment from 2019. At the end of 2020, a total of sixty-five teachers were actively employed at Launceston Christian School. Of these, one teacher retired, two were temporary replacements for teachers on extended leave, and one took up employment interstate.

All teachers employed at Launceston Christian School in 2020 were registered with the Tasmanian Teachers Registration Board (TRB) and held a current Working With Vulnerable People (WWVP) card.

## Professional Learning Expenditure and Teacher Participation

In 2020, The Middle and Senior Schools completed 'in house' professional learning in moderation of AC courses using the SWING protocol and the National Consistent Collection of Data for students with disabilities. In addition, in preparation for online learning during the COVID lockdown in April, all teachers (from K-12) spent time developing and/or implementing an online learning policy and practice. Teachers also spent significant time learning the software applications to use as a part of online teaching and learning. All teaching staff also worked in Year groups (K-6) or Learning Area groups (7-12) as part of the Educator Impact Program based on improving teaching practice.

The Education Support Unit staff participated in two significant professional learning opportunities. The first of these was with Mrs Robyn Thomas on "The Structured Teaching Approach for students on the Autism Spectrum". The second opportunity was a series run in-house by Mr Brad Robinson on the use of Microsoft Teams in preparation for remote learning. Yearly professional learning on work, health and safety and the induction to the technology workshop were also undertaken.

During 2020, Junior School staff began to implement a consistent approach to term planning using Transformation by Design to make biblical perspectives more explicit to the students. They focused on identifying big questions that linked key content and used them to shape each term's curriculum. Remote learning triggered the need to develop online teaching skills. The staff worked informally in peer and cluster groups to develop videoing and class page management skills on The Hub and other learning tools. The rapid uptake of skills was consolidated during the year and has continued to impact student learning positively. The Junior School continued a regular moderation schedule in various learning areas during Terms One and Three.

Depending on previous training completed, all Staff completed either the "CPR refresher" course or the "Provide first aid" course through St John's Ambulance at the start of the school year.

Years 11 and 12 teachers attended TASC Course Moderation Meetings provided by the Department of Education and TASC Quality Assurance meetings, where required.

### Student Attendance

The average daily rate of attendance for students in prep to year 10 in 2020 was 91.23% of the total number enrolled.

## Senior Secondary Outcomes

Forty-eight students were enrolled in year 12 at Launceston Christian School in 2020. Forty-four (92%) of these students achieved a Tasmanian Certificate of Education (TCE), and thirty-one (65%) qualified for an Australian Tertiary Admissions Rank (ATAR). The mean ATAR for this group was 81.5. Sixteen students (33%) completed Vocational Education and Training as a part of their senior schooling.

### Student Retention

The following information relates to the retention of students from 2019 into 2020. The percentage enrolment retained is a calculation based on the number of students enrolled in the year group from February 2020.

# School Performance and Forward Planning

#### Student Welfare

2020 was a challenging year for LCS students who experienced schooling from home and the subsequent mental health issues resulting from isolation and return to classroom learning. The School Wellbeing Unit counselled students dealing with anxiety around both scenarios.

An evaluation tool for mental health wellbeing, PULSE, was introduced for students from years 5-12. Students rated their wellbeing on a weekly basis and the programme alerted teachers and Wellbeing Unit staff to students requiring special support.

Wellbeing staff attended training relating to Cybersafety and Bullying to further assist students in dealing with relationship issues.

### Workplace Health and Safety

The School's Workplace Health and Safety Committee meet once every term to review incidents, potential hazards, risk assessments, and incursion/excursion debriefs. The Committee reports to the Board on their deliberations, including any resolutions and recommendations arising.

### Policy Management

The School continues to use the *Complispace* policy management tool for all its policies. The Board of Directors and the Leadership Team of LCS regularly review the School's policies and update or adjust where appropriate.

Several policies were updated throughout 2020. Most notable among these were the Child Protection Policy Suite, the Critical Incident Pandemic Policy, and the Infectious Diseases Policy.

### Strategic Plan

Principal Adrian Bosker and the School Board officially launched the School's Strategic Plan in November 2020. The plan is divided into five key domains: Teaching and Learning; Student Wellbeing; Culture & Community; Governance & Leadership; and Infrastructure. In each domain, the strategic plan describes what Launceston Christian School ASPIRES to ACHIEVE and BECOME, and lists the types of activities, programs and planning that needs to take place to achieve these goals.
