Association Membership builds upon this partnership; creating opportunities for parents, past students and friends to maintain the schools direction, providing Christian education based on the Bible.

WHAT IS THE ASSOCIATION?

Our school is owned by the Association for "Launceston Christian School Inc." and it is a legal body

The Association was formed in 1965 by committed Christians in Launceston who saw a need for Christ centred education for children

It elects directors to the LCS Board who are responsible for the school's governance, policy and direction



WHY CONSIDER ASSOCIATION MEMBERSHIP?

Recognise Jesus Christ as Lord of all Maintain the Christian distinctiveness of the school

Have a voice in decision making and maintaining the direction of the school Participate and serve in our community, focussed on Christian Education Be eligible for nomination and election to the Board of Directors

Membership is not automatic when you enrol your children at the school – you need to apply

WHO CAN BE AN ASSOCIATION MEMBER?

Christian parents, past students and friends of the school community can apply for membership

There are two types of membership:

Full Membership is open to professing Christians who can sign the following declaration: "I declare my faith in the Lord Jesus Christ as my Saviour, Lord and God and my whole-hearted acceptance of and agreement with the Objects of the Association as defined in Clause 4 of the Constitution."

Associate Membership allows members similar rights and duties as a full member including service on committees such as the Building and Grounds committee or the P&F. However, Associate members cannot vote on changes to the Constitution, Board or be elected to the Board of Directors. It is open to professing Christians who can sign the following declaration: "I declare my faith in the Lord Jesus Christ as my Saviour, Lord and God and my whole-hearted acceptance of and agreement with the Educational Creed annexed to the Constitution of this Association."

HOW TO BECOME AN ASSOCIATION MEMBER?

The Association Pack contains membership forms. The School Constitution, Educational Creed and information on: The Belgic Confession, Heidelberg Catechism, Canons of Dort and The Westminster Confession are available on our website - www.lcs.tas.edu.au

Fill out an Association Membership form and return to the school office

Have an interview with two members of the LCS Board (a Board member will contact you)

The Board formally considers your application for membership at the next Board Meeting

Cost of Association Membership is \$55 per year. Current families at the school have this fee waived.

Associate Members have the same rights and duties as full members except **they cannot vote** on changes to the Constitution, Board Member elections or be elected to the Board of Directors

Helpful notes:

- A copy of the LCS Constitution and Education Creed referred to in the application forms are included in this pack.
- The Belgic Confession, Heidelberg Catechism, Canons of Dort and The Westminster Confession of Faith are statements of Biblical belief developed in the 16th and 17th Centuries. They are commonly used by the Reformed thinking denominations as their Statements of Faith.
